# Pam Wortley Central Council



I am a retired GP and have been a member of the Labour Party, the SHA (SMA), and Doctors in Unite (ASTMS/AMICUS) for over 50 years.

The NHS is the greatest example of socialism in action. The SHA, Socialism in its title, is essential to the endeavour to get the NHS back from the privateers and to maintain its ethos - a comprehensive, universal, publicly funded, publicly owned, and publicly accountable NHS, free at the point of use, with the resources needed to

## Mark Ladbrooke Chair



If re-elected as chair I promise to deepen our current political approach. The SHA must remain an active organisation which campaigns for our principles on the conference floor, the picket line and on the streets. Our position is to re-instate the NHS as a public service rather than a mere commissioning agency which doles out shrinking public funds to parasitic health corporations. This year we have again taken this argument to Labour Conference, fringe events, the Durham Miners Gala and our major London NHS75 Conference.

We are socialists and in over 90 years of our existence our views have not always been popular with the leadership of the Labour Party. This is true today as Labour shifts to the right in a bid for respectability. The SHA is an independent organisation. When the Labour leadership gets it wrong we tell them. We choose to affiliate to Labour and they agree to accept our affiliation.

We should be proud that we used the 75th anniversary of the NHS to build links with Labour leaders, social justice campaigners, trade unionists and radical minded academics. We need a Labour government but that alone will not resolve the awful legacy of 14 years of Tory rule. Our campaigning will need to continue.

The trade union movement is important - the power of solidarity and collective bargaining is a huge leveller. Whatever the complaints of the Telegraph - we will back union struggles. We also are absolutely committed to working with communities and activists.

In the last year our international work has developed rapidly particularly around protests regarding the unfolding tragedy in Gaza. Our stance is quite rightly humanitarian.

I am hugely privileged to be part of a strong leadership team which includes all our active members. Huge thanks to you all for your support.

## Carmel Maria Cadden Central Council



My work experience was in adult and secondary education, with a few years as a community networker in Haringey. My daughter is a senior registrar so I'm aware, to some extent, of what's involved in working in the NHS.

Inspired by Corbyn, I joined the Labour Party in 2015, and was a branch secretary in Tottenham CLP from 2018 – 2022. I'm Environment Officer in my local Unite Community branch and part of the Haringey Community

Action Network.

I strongly believe that all NHS services should be carried out by the NHS which must be publicly owned - and democratically accountable.

I'm a member of the Right To Food campaign which aims to make it a statutory requirement for government to take responsibility for the policies they impose that lead to food insecurity. As food bank volunteers, we are uncomfortably aware that we're filling the gap left by government policies that result in poverty wages, unaffordable rents and homes unfit for human habitation. Poverty and poor diet have become serious public health issues, so I support more emphasis on public health and the social determinants of health – and if elected, I would like to serve on the food security working group.

I want to see improvements to NHS services, not just defending what already exists: mental health services in particular, need more resources. NHS staff should have access to a free counselling to help them cope with the after-effects of traumatic work experiences.

There should be more support for NHS work on international health issues – I believe it's vital that medical skills and experience are shared.

All my life the NHS has been there for me - I want to ensure it's there for future generations too. We just need the political will.

#### **Barbara Roberts Vice Chair**



I'm a disabled person and socialist campaigner. Member of the Labour Party for the last 13yrs, currently Disability Officer for my CLP of Hackney South.

As an exec member of Disability Labour I've been vocal in calling for a Social Care system which works for all, being the co-author of the Social Care motion Disability Labour submitted to both Women's and National Labour Party conferences.

As a vice-chair of the SHA Central Council I'd continue to be a voice for disabled people. To educate, campaign and develop the policies disabled people desperately need Labour to implement. Full accessibility, especially of meetings and total inclusion. All ableism must be stamped out. And thus any policies the party, once in government, wishes to implement must be drafted co-productively with disabled people.

The emphasis being on the Social Model of Disability, which looks at the differing ways in which people with disabilities and impairments encounter the social restrictions or barriers our society throws at them and of changing the social organisation of society in order to accommodate people with impairments.

I support and will continue to campaign for the creation of a National Care Service. A service that works for people with disabilities, publicly provided and free at the point of use foremost.

I fully support the SHA motion which was passed at the 2022 Labour Party Conference - the NHS must also be a publicly funded, publicly accountable and a publicly provided service. Selling off the NHS by privatisation simply must be halted.

# **Jatinder Hayre Central Council**



As a Medical Doctor and Health Inequality researcher, my professional and personal experiences equip me with the skills to be an effective member of the central council. In 2020, I co-authored the authoritative 'SAGE Report 21: COVID-19 and Health Inequality', I've previously been on The Fabian Society Health Network executive committee, I'm the national spokesperson for 'Keep Our NHS Public' and have worked alongside John McDonnell in 'Reclaim The Future'. During the pandemic I worked with 'The

Population Health Sciences Institute' to shine a light on Government policy and cronyism. And currently I am based in Health Equity research at QMUL. At the SHA, we must set the agenda to preserve our NHS and address health inequity.

In addition to this, I have authored multiple academic papers on health inequity and the social determinants of health. Including, a recent review investigating children's health inequalities through the pandemic. I envisage a proactive and productive SHA, I will unite my campaigning, clinical, and academic background to contribute to the role effectively and to the discourse, especially on the following policies and pledges:

Addressing health inequality and the social determinants of health during the cost-of-living crisis.

- Commit to a paradigm shift away from destructive austerity, towards widescale reinvestment based on proportionate universalism.
- Promoting a publicly-funded, publicly-provided NHS, opposing privatisation wherever and whenever we can.
- Committing to a national social care system.
- Opposing the bypassing of general practice as gatekeepers through selfreferral mechanisms
- Engaging in future pandemic preparedness.
- Endorsing a "health in all policies" agenda.
- Declaring a state of emergency in the NHS.

Together, utilising our collective experiences, we can create an SHA that is a powerful organising, campaigning, and policy force within the Labour Party.

## **Pat Schan Central Council**



My name is Pat Schan and I would like to be considered again for Central Council of the SHA. I am a retired Midwife with over 45 years service in the NHS. My final role was as a clinical advisor to the National screening programme for Infectious Diseases in pregnancy working on a national review of the uptake of Hepatitis B vaccinations in babies. This work complemented my socialist beliefs in equality and access in health care to

all, especially the most vulnerable in our communities.

Last year at the SHA World Transformed fringe at Labour conference, I chaired a very successful SHA event discussing the NHS at 75 which attracted over a hundred attendees and created some powerful discussions.

I passionately believe in the NHS and support all campaigns to keep it public and fully funded .

### **Anne Brown Central Council**



I am Anne Brown, a retired teacher from Newcastle upon Tyne. I am proud to call myself a socialist and I profoundly believe that the NHS, as it was created in 1948, is one of the Labour movement's and this country's greatest achievements:it is, or should be, socialism in action.

I am standing for SHA Central Council because I am incredibly concerned about what is happening in the NHS and I am fearful that, even if a Labour Government is

elected, things will not improve. Already the founding principles of the NHS are being chipped away by stealthy privatisation. When Labour MPs including the party leader and the shadow health secretary are in receipt of donations from private health companies, it is incredibly worrying.

In terms of actual health provision, the two areas that I am especially concerned about are preventative medicine and the provision of mental health services. It seems ridiculous that lack of funding and austerity lead to a lack of provision that means patients miss out on early diagnosis and treatment which can have catastrophic consequences as well as being a drain on NHS resources.

I also believe passionately that mental ill health should be treated with the same urgency as physical illness. At the moment there is still too much stigma attached to mental illness and far too little provision, especially for young people.

If elected I will represent the views of those who believe in a fully funded and democratically accountable NHS. Public services should be exactly that, not businesses for shareholders.

### **Julius Marstrand Central Council**

Julius is an active campaigner for the local NHS in Gloucestershire, a Board Member and media spokesperson of Restore Emergency At Cheltenham Hospital (REACH) [ https://www.facebook.com/REACHospital ], REACH was founded in 2013 in response to the downgrading of the local A&E Department.

REACH is a cross-party campaign which has the support of three District Councils and three MPs. That has made it more difficult for the Hospital Trust to downgrade the Department to an Urgent Treatment Centre.

Although not a clinician, he got involved in campaigning for the NHS and Adult Social Care while working for a local charity representing the needs of older people, who inevitably have the highest level of clinical and social care needs. Through his involvement with the NHS, he stood and was elected as a Public Governor of the local acute Hospital Trust and served for seven and a half years.

He has a particular interest in 'good governance', 'openness and transparency' and the treatment of 'whistle-blowers' in the NHS. He has a network of informants in the local NHS, from Hospital Consultants to frontline A&E staff and paramedics, who keep REACH supplied with information.

Julius is opposed to further privatisation of the NHS and the outsourcing of NHS procedures to the private health sector - it is mostly the same Hospital Consultants who work in the private sector as work in the NHS anyway. He is also opposed to the run-down of local Community Health Services, from Community Hospitals to District Nurses, Health Visitors, Occupational Therapists. Podiatrists, GPs and Dentists, which is what is putting increased and unsustainable pressure on A&E and other Departments.

## **Carmen Williams Central Council**



I came to the UK fifty years ago and for many years taught modern languages in comprehensive schools. After getting an MA in TESOL, I spent the last years of my career as ESOL manager in FE. My teaching was guided by socialist approaches that promote a just and more equal society where no-one's left behind.

A Unite Retired member, I engage in grassroots branch activism. As a PSC and JVL member I actively support Palestinians' right to freedom from Israel's occupation, apartheid and genocide. Still a Labour Party member, I've been

CLP Women's Officer and conference delegate. I defend party democracy, under attack from a leadership intent on stifling debate. I have written policy motions to support equality, social justice and internationalism and counter militarism, austerity and racism.

We need a publicly-funded and publicly-delivered NHS. Years of privatisation and underfunding compared to need have left the NHS in crisis. I joined the SHA because of its opposition to privatisation and commitment to a fully-funded and fully-public NHS.

A recent King's Fund report exposes the UK's below-average spend per person, compared to the health systems of 18 other similar countries. Under current Labour fiscal policy it's unlikely the additional levels of funding the NHS needs will be readily provided.

Privatisation drains NHS resources and must be reversed. Emerging evidence suggests that representatives of private healthcare corporations, currently allowed to sit on ICBs, will have a prominent role in making decisions about our healthcare. Profits will guide these decisions, with care quality suffering as a result. Action is needed. However, Wes Streeting's "reform" cannot be the answer if it means turning to those corporate interests which have helped to destabilise and severely undermine the NHS.

If elected, I will promote policies that reflect SAH's internationalism, address NHS needs, and counter privatisation.

## Julian Williams Central Council



We all have our own personal experiences and trauma in health and in deings related to the NHS and its current decline. I speak as an immunologically compromised older patient under more Health Centres than I care to mention (Heart, Lungs, ...) and have been astonished at how I'm now dealing with all these private companies who 'service' the NHS as contractors from GP and consultants. Even some my GPs are in private practice apparently benefitting from being specialists they refer themselves to!

However, let me declare my main interest in SHA. I am an academic and activist passionately but mainly engaged in education, and in education for tackling the global emergencies of climate and biodiversity breakdowns. This leads me to health, which I clearly see as being implicated centrally in these problems. As the planet overheats we will see increasing social crises of health, and as biodiversity decays we will experience more and worse pandemics. A major and essential concern in these health crises is already and will in future be educational. You can make vaccines but you have to educate people to take responsibility.

At the same time I argue that these are global problems: there is little point in fixing vaccines in the UK if the pharma profits make international immunisation impossible.

I hope the SHA will provide an opportunity to discuss these important concerns. I am a convenor of research/working groups on 'Green Research in Education', and 'Free speech/freedom for Palestine' and I would expect to be proactive in similarly promoting such causes in SHA from the CC.

## **Caroline Bedale Central Council**



I campaign in the SHA and other organisations, including the Labour Party, to rebuild the NHS as a publicly funded, publicly provided service. In an election year SHA working groups could provide useful information for Labour candidates and voters, and I will help with this. With the NHS in crisis the SHA must campaign harder to try to ensure Labour Party manifesto policies are consistent with Conference resolutions, and challenge the leadership's apparent acceptance of Tory funding policies and private sector delivery of NHS services.

As a retired NHS worker, UNISON activist and socialist, I deplore the Tories' continuing attacks on the NHS. Years of austerity and encouragement of parasitic private sector profiteers draining resources meant the NHS was poorly equipped to fight covid and its aftermath. Tories have failed to provide sufficient resources for new building, refurbishment and maintenance, so staff often work in inadequate, unsafe buildings. Tories have failed to address staffing shortages or pay staff enough, or provide resources to reduce waiting lists. There is still no parity of esteem for mental health services. Growing health inequalities and falling life expectancy, especially for people from black and minority ethnic heritage, are shocking results of the government's deliberate policy to run down the NHS. Ignoring the real problems of social care, that many care homes and domiciliary services are owned by companies answerable to shareholders not service users, Tories have slashed local authorities' budgets so they cannot meet people's needs.

Please vote for candidates who support a member-led SHA fighting health inequality here and internationally, actively campaigning to defend and improve the NHS and social care.

# **Judith Kramer Secretary**



I am applying to be elected to the role of Secretary of the SHA, I have held this role since November 2023 when I took over from Harry Stratton following his resignation. Prior to this I was a Greater Manchester representative on the Central Council, elected in Feb 2023.

In my brief time as Secretary I have been familiarising myself with the Action Network system and the Admin emails peculiarities.

Hello, I am a registered BACP Person Centred Counsellor, trade unionist at migrant led, low-paid workers United Voices of the World, former youth worker, Councillor and the Mental Health Champion for the London Borough of Hackney. I hope to count on your vote for Central Council.

My passion for universal healthcare began from my childhood years where neoliberal governments in my native Bolivia meant my family couldn't readily access basic healthcare and treatment, on many occasions relying on international relief programmes to access dentistry care,

emergency treatment and even surgery costs.

I've also seen how programmes that have aimed to sterilise women in my communities, targeting specially indigenous women with the pretext of a promise to overcoming socio economic hardship. On my arrival to the UK, like many migrants, I was denied GP registration for nearly three years.

These are some of the inequalities that makes me passionate to fight for access to universal healthcare, for keeping the NHS public, free from privatisation.

As a mental health Person Centred Counsellor, I founded a mental health project that has been offering free counselling therapy and workshops for Hackney residents since 2018 and also launched a petition addressed to then Prime Minister Theresa May demanding mental health care to be our human right and not a luxury, 13,000 people signed it.

As a Labour Councillor in Victoria Ward, Hackney I have continued with my determination for mental health care support resulting in my motion Mental Health a Human Right for All being adopted by Hackney Council last September.

As you can see I have a long track record of continued, proactive work in the health sector, I believe I have the skills, passion and commitment to do my best representing you and our communities health needs at Central Council.
